JustUs Health is an organization formed from the merger of the Minnesota AIDS Project (MAP) and Rainbow Health Initiative (RHI). The merger was effective January 1, 2018. This report contains financial information and other important from JustUs Health' predecessors.

JustUs Health combines the direct service, advocacy and HIV education that MAP has provided; along with the research into LGBTQ health disparities, tobacco policy work, and LGBTQ equity and inclusion training that RHI has provided. Our vision is for "a Minnesota where people from diverse gender, sexual and cultural communities experience health and wellness in powerfully inclusive environments."

Our merger laid the groundwork for the launch of JustUs Behavioral Health, our new clinic that offers mental, chemical and sexual health services for LGBTIA+ people, people living with HIV, and folks from communities that face barriers to behavioral health support. When combined with JustUs Health's care coordination, education and support services, we are now able to offer a continuum of comprehensive and integrated health services in a safe and supportive environment. Our research into health disparities helps us understand and address the issues that many of our clients have faced in the broader health care system.

This report summarizes the performance of the Minnesota AIDS Project and Rainbow Health Initiatives in 2017, their last year as separate organizations.
